This form must be completed by the perent or other legal guardian of the child in his/her own handwriting. When the marriage of the parents have been disolved, or in any case when someone other than the parent signs the apoplication, evidence of the legal guardianship should be produced with application.

Note-The any other person claiming legal custody during the lifetime of the perent, must produce the court order committing the child to that person's custody.

DOCUMENTS TO BE PRODUCED

Applicants should produce to the Passport Officer the Child's Birth Certificate, Certificate of Naturalisation or Registration where applicable.

Persons claiming Citizenship of Zambia by descent, will be required to produce documentary evidence in support of their Statement at Section 3.

IN THE CASE OF AN APPLICANT WHOSE REGISTRATION OF BIRTH WAS NOT COMPULSORY HE SHOULD SUBMIT AN AFFIDAVIT OF BIRTH IN THE PRESCRIBED FORM.

PHOTOGRAPHS

Two copies of a recent photograph of the child must be included with this application. These photographs must be taken full face without hat, of head and shoulders, and the photographs must not be mounted. The size of the photographs must not be more than 6cm by 5cm nor less than 5cm by 4cm. The photographs must be printed on normal thin photographs paper and must not be glazed on the reverse side. The witness is also required to endorse the reverse side of one copy of the photograph with the words 'I certify that this is the true likeness of the applicant Mr or Miss....' and add his signature.
